1 Introduction

The Environmental Impact Assessment (EIA) Report (Register No.: AEIAR-185/2014) prepared for the “Expansion of Hong Kong International Airport into a Three-Runway System” (the project) has been approved by the Director of Environmental Protection, and an Environmental Permit (EP) (Permit No.: EP-489/2014) has been issued for the project under the Environmental Impact Assessment Ordinance.

The purpose of this updated Management Organizations is to provide the latest information based on the recent contracts awarded under this project. This updated Management Organizations includes the following information:

- a) the management organization of the main construction companies and/or any form of joint ventures associated with the construction of the Project (in Section 2);
- b) the management organization of the Environmental Team (ET) (in Section 3);
- c) the management organization of the Independent Environmental Checker (IEC) and his team (in Section 4); and
- d) organization charts, names of responsible persons and their contact details.

2 Management Organization of the Main Construction Companies

2.1 Advanced Works Contract

Langfang Huayuan Mechanical and Electrical Engineering Co., Ltd. (Contract P560(R)) is the contractor appointed to undertake the diversion of the existing submarine aviation fuel pipelines. Names of the responsible persons and their contact details are set out in **Table 1** below.

2.2 Deep Cement Mixing (DCM) Works Contracts

Penta-Ocean-China State-Dong-Ah Joint Venture (Contract 3201), Samsung-Build King Joint Venture (Contract 3202), Sambo E&C Co., Ltd. (Contract 3203), China Road and Bridge-Sambo Joint Venture (Contract 3204) and Bachy Soletanche-Sambo Joint Venture (Contract 3205) are the contractors appointed to undertake the DCM ground improvement works. Names of the responsible persons and their contact details are set out in **Table 1** below.

2.3 Main Reclamation Works Contract

Zhen Hua Engineering Company Ltd.-China Communications Construction Company Ltd.-CCCC Dredging (Group) Company Ltd. (ZHEC-CCCC-CDC) Joint Venture (Contract 3206) is the contractor appointed to undertake the main reclamation works. Names of the responsible persons and their contact details are set out in **Table 1** below.

2.4 Airfield Works Contract

Fujita Corporation-China Harbour Engineering Company Ltd.-Zhen Hua Engineering Company Ltd. (FJT-CHEC-ZHEC) Joint Venture (Contract 3301) is the contractor appointed to undertake the construction works for the north runway crossover taxiway. China Road and Bridge Corporation (Contract 3302) is the contractor appointed to undertake advance works for the eastern vehicular tunnel. 2.5 Third Runway Concourse and Integrated Airport Centers Works Contract

Wing Hing Construction Co., Ltd. (Contract 3402) is the contractor appointed to undertake enabling works for the new Integrated Airport Centres. Names of the responsible persons and their contact details are set out in **Table 1** below.

2.6 Terminal 2 Expansion Works Contracts

Build King Construction Ltd. (Contract 3501) is the contractor appointed to undertake the construction works for antenna farm and sewage pumping station. Build King Construction Ltd. Leighton-Chun Wo Joint Venture (Contract 3503) is the contractor appointed to undertake T2 foundation and substructure works. 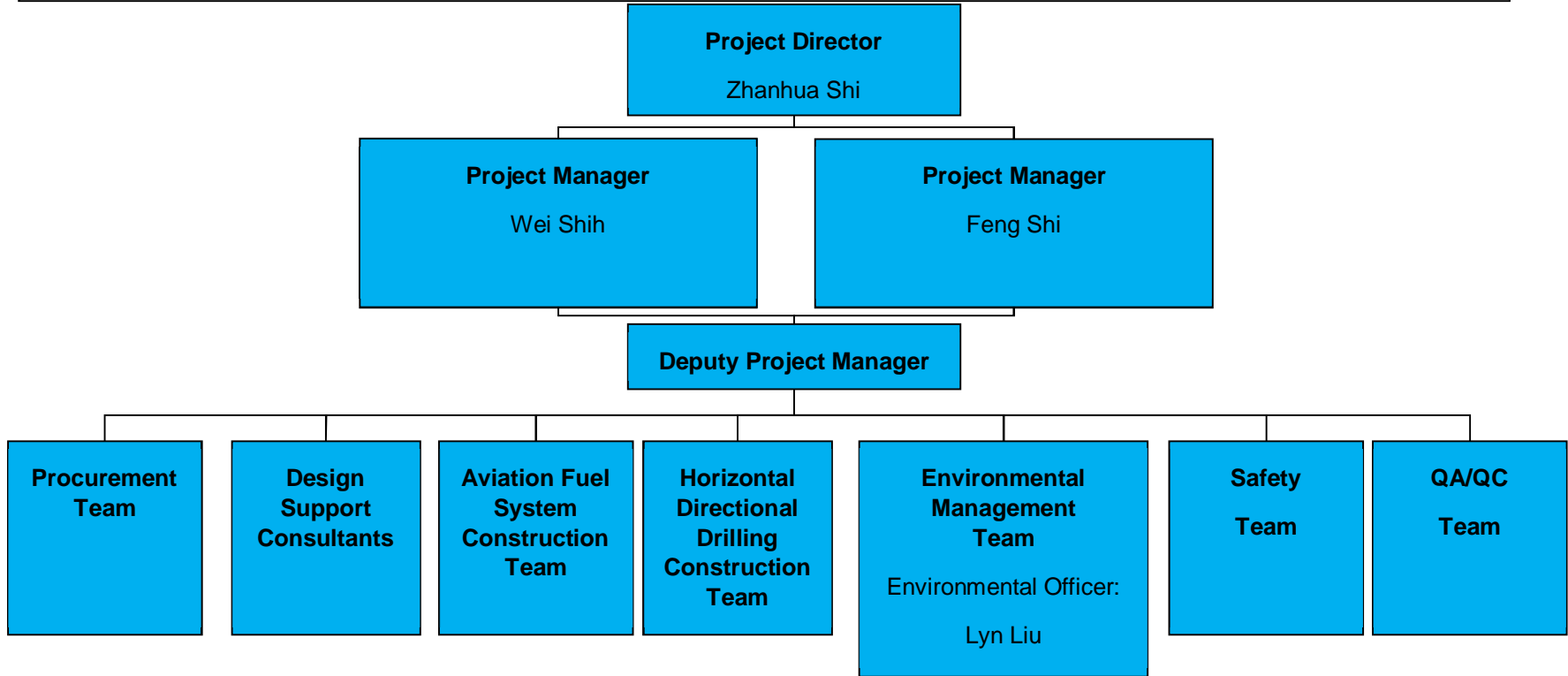

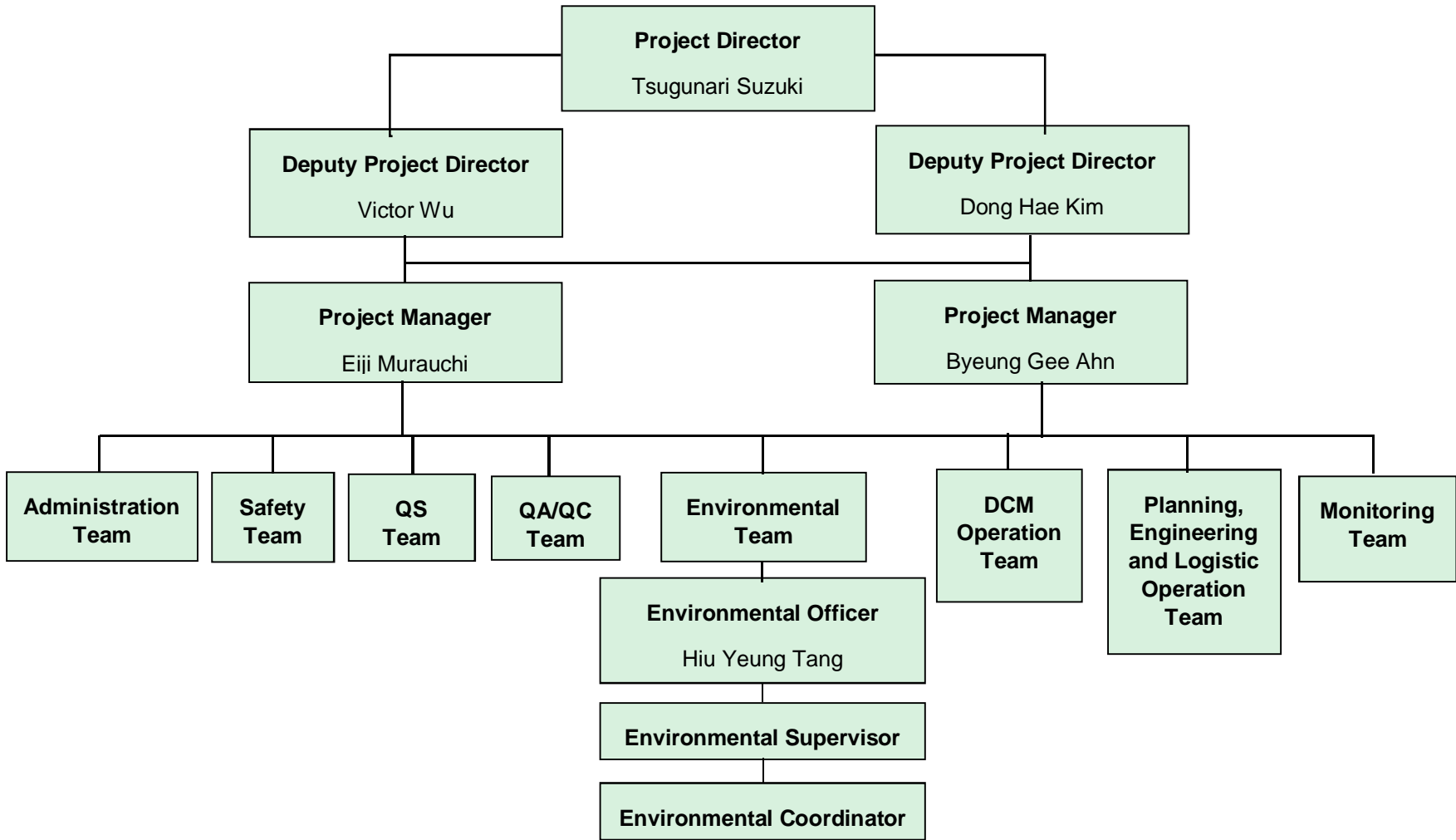

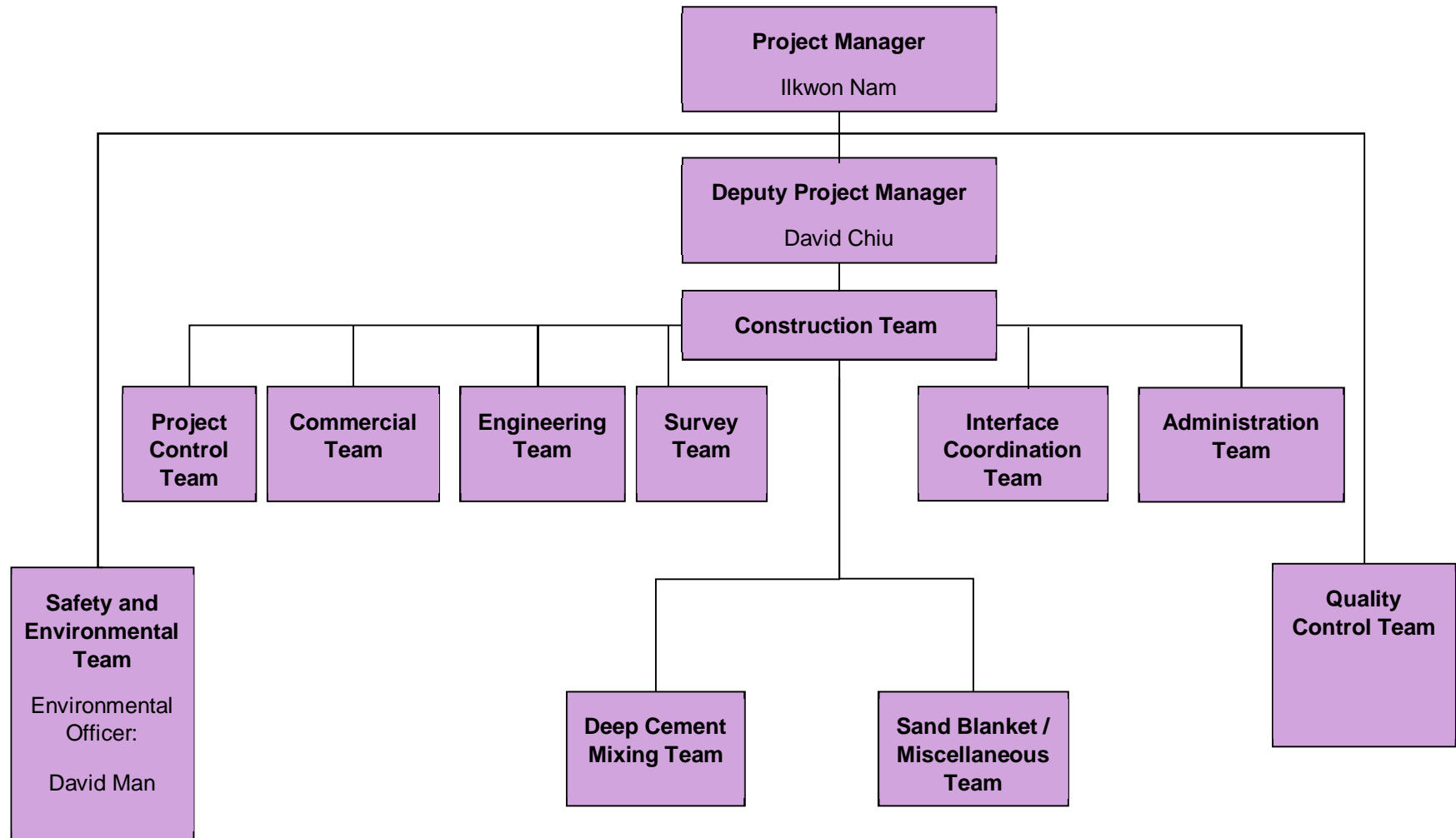

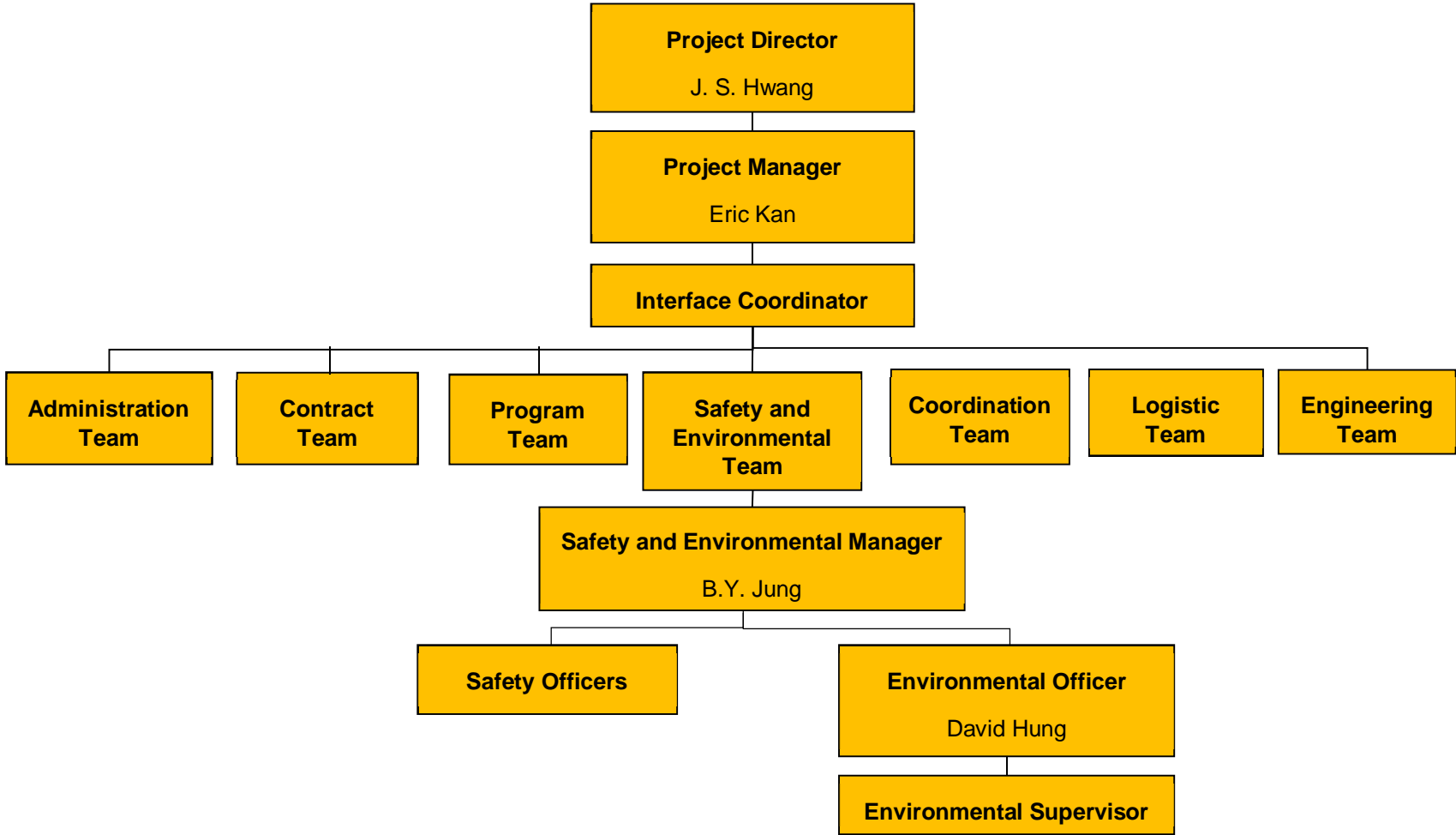
Organization Chart of Penta-Ocean-China State-Dong-Ah Joint Venture (Contract 3201) for Deep Cement Mixing Works (Package 1)



Organization Chart of Samsung-Build King Joint Venture (Contract 3202) for Deep Cement Mixing Works (Package 2)



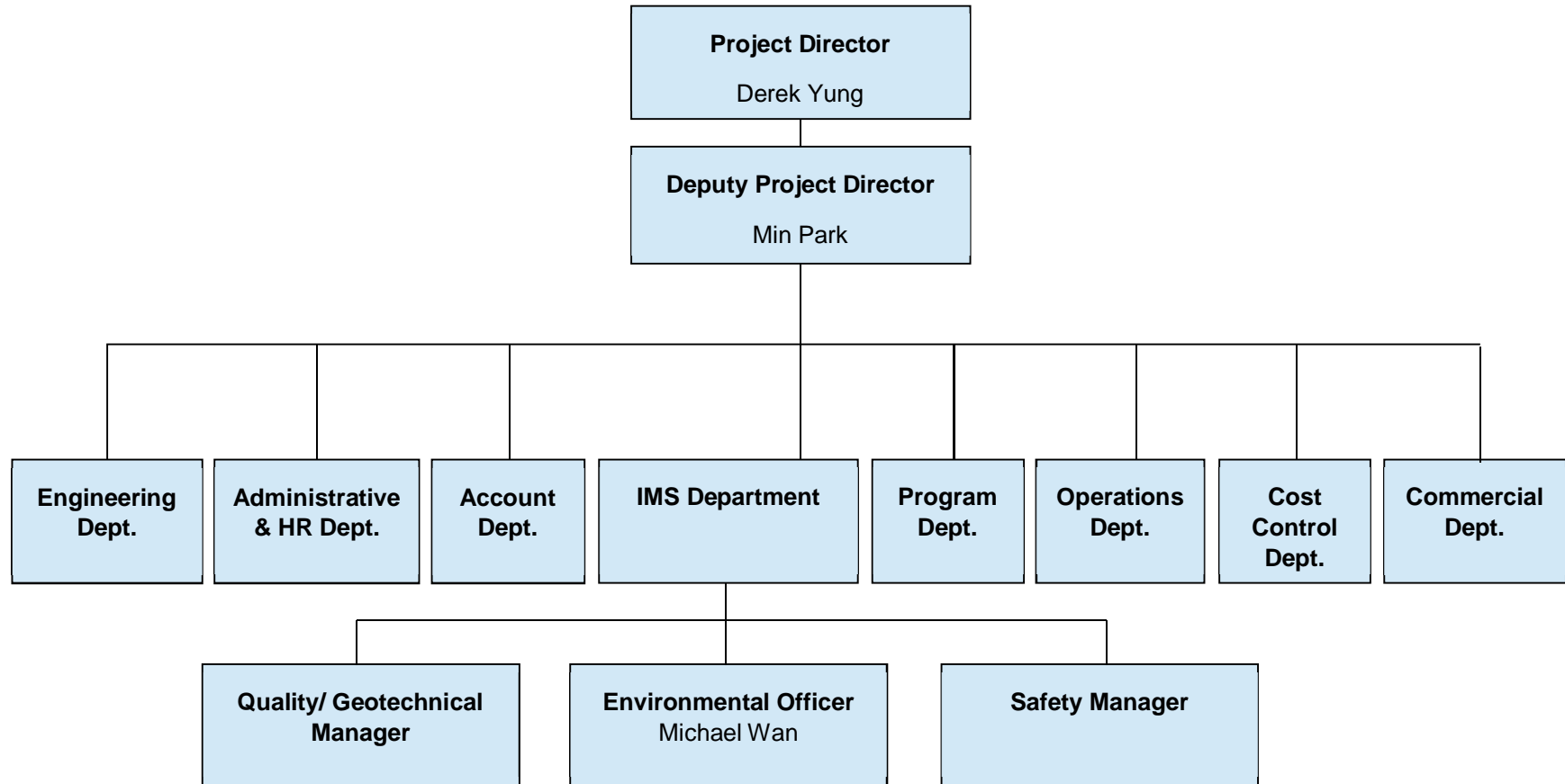
Organization Chart of Sambo E&C Co., Ltd. (Contract 3203) for Deep Cement Mixing Works (Package 3)



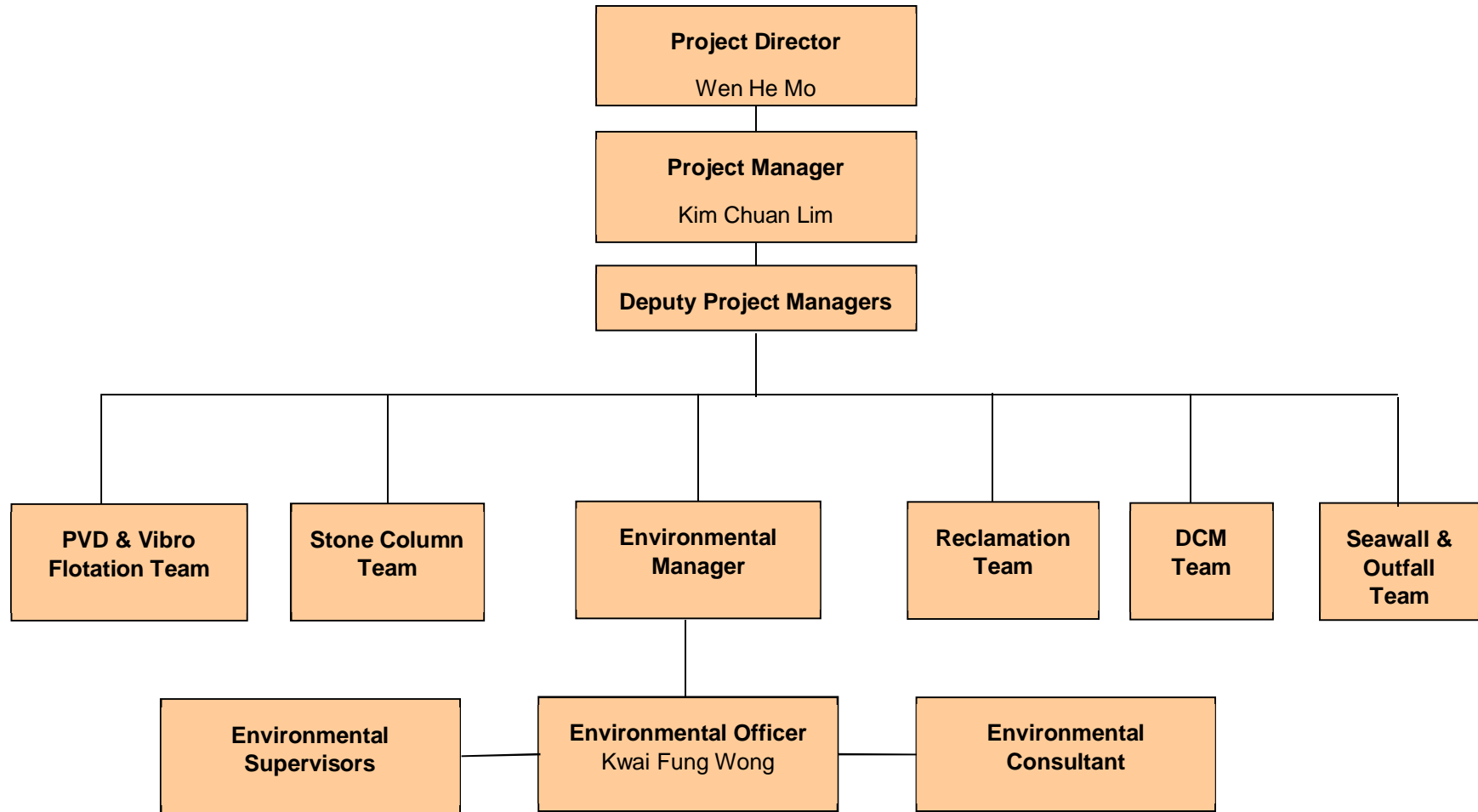
Organization Chart of CRBC-Sambo Joint Venture (Contract 3204) for Deep Cement Mixing Works (Package 4)



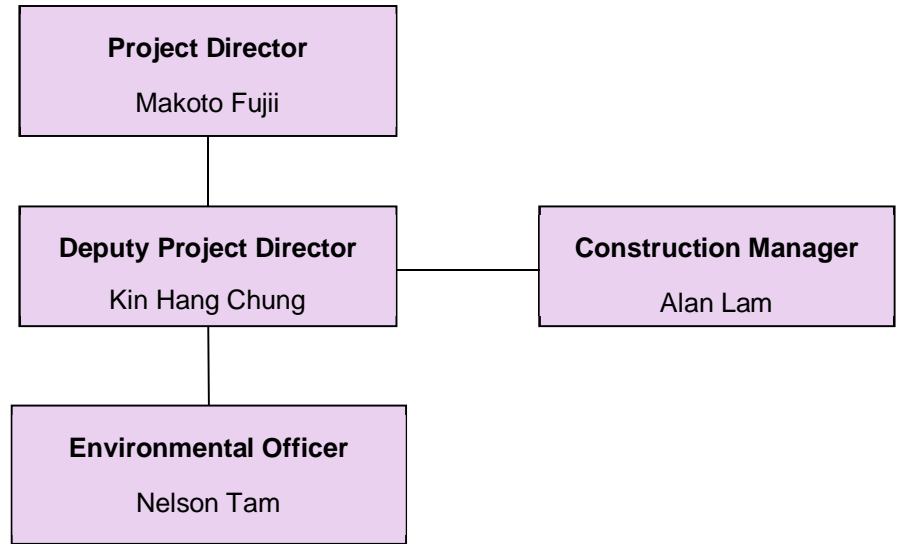
Organization Chart of Bachy Soletanche-Sambo Joint Venture (Contract 3205) for Deep Cement Mixing Works (Package 5)



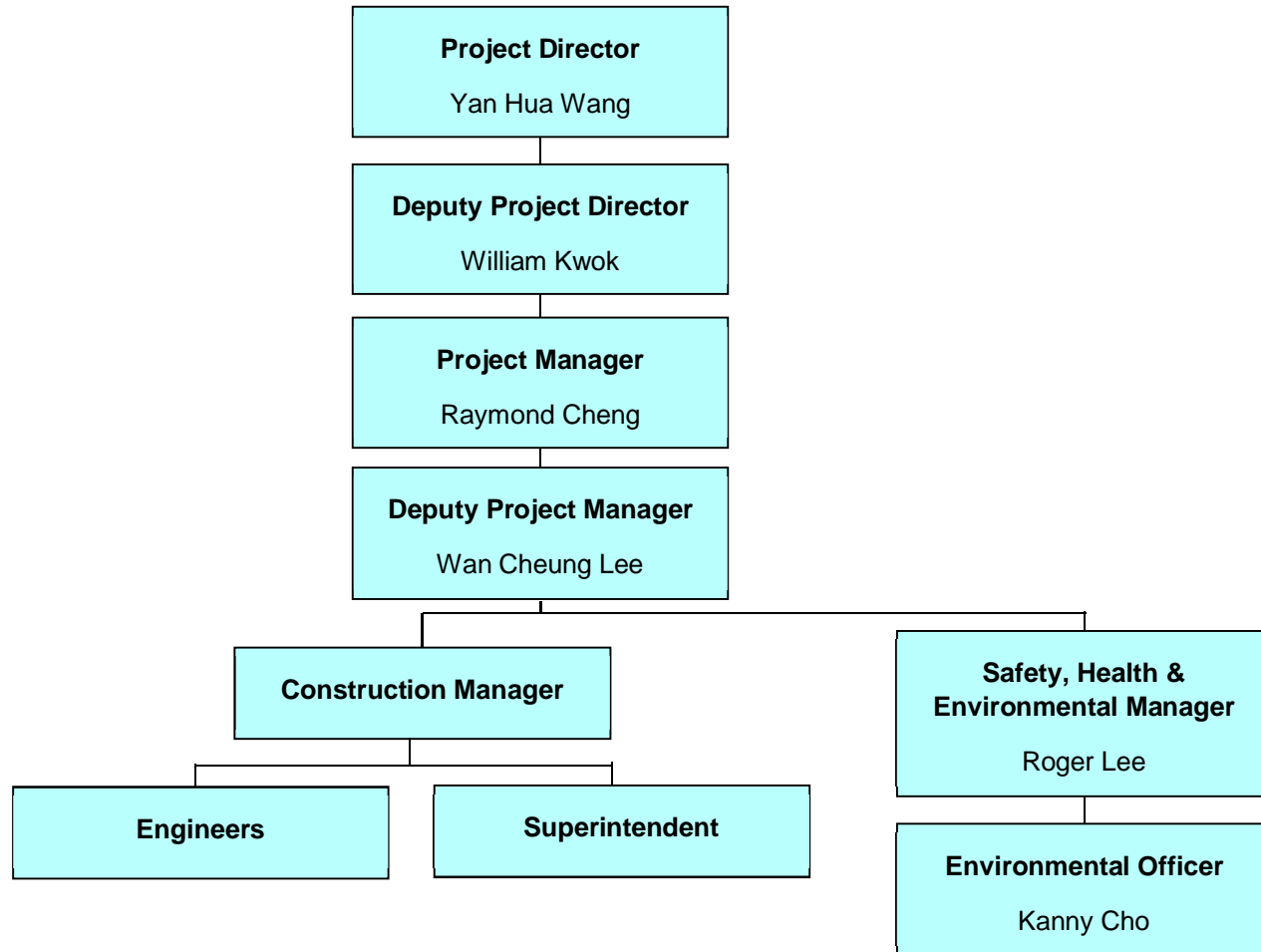
Organization Chart of ZHEC-CCCC-CDC Joint Venture (Contract 3206) for Main Reclamation Works



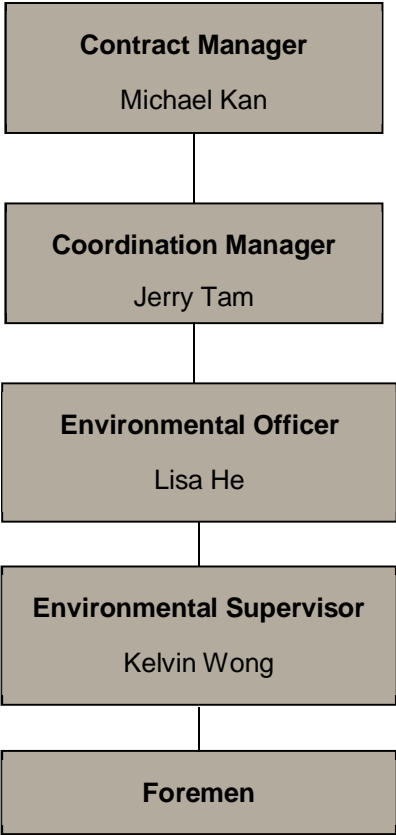
Organization Chart of FJT-CHEC-ZHEC Joint Venture (Contract 3301) for North Runway Crossover Taxiway



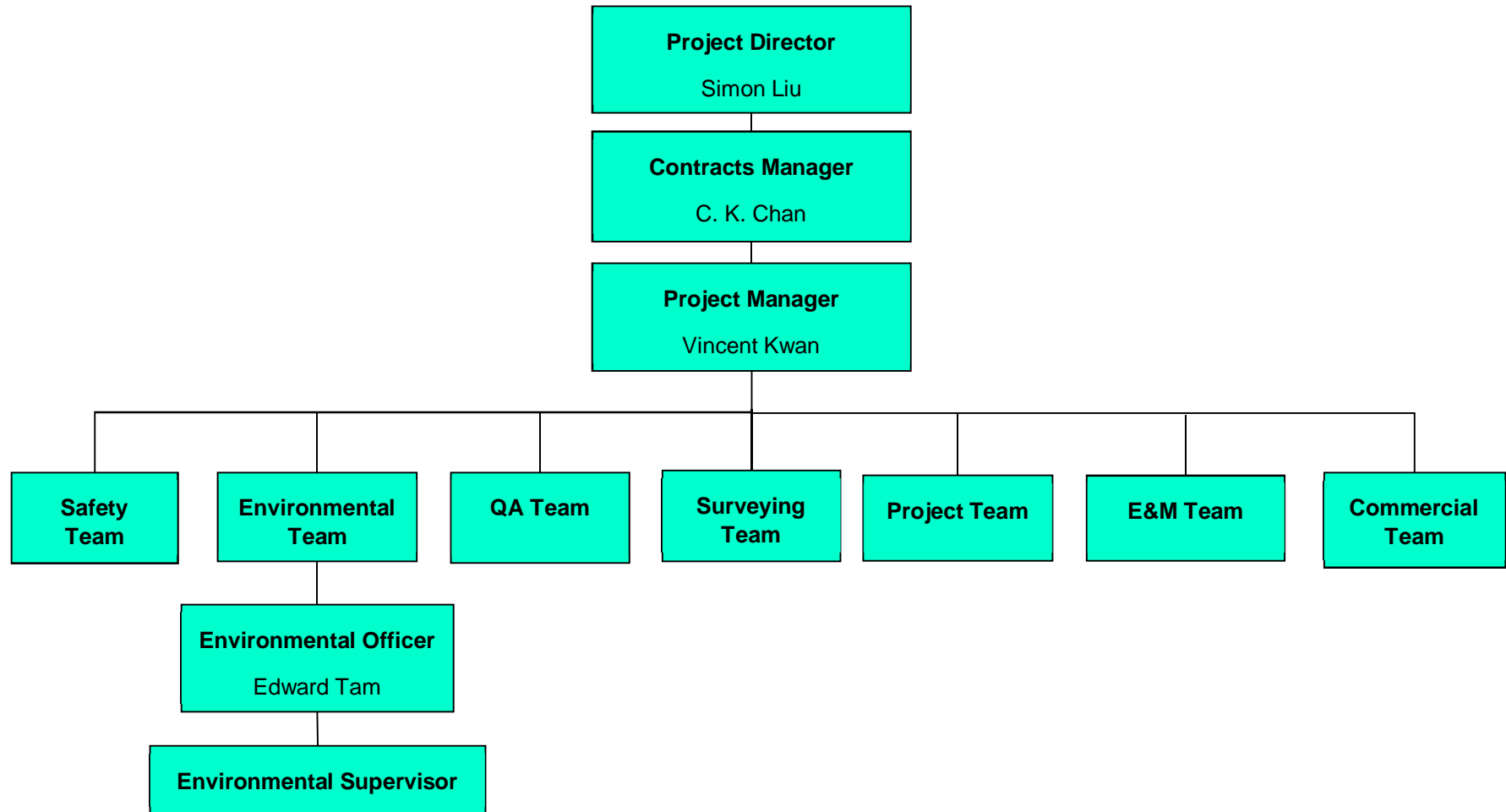
Organization Chart of China Road and Bridge Corporation (Contract 3302) for Eastern Vehicular Tunnel Advance Works



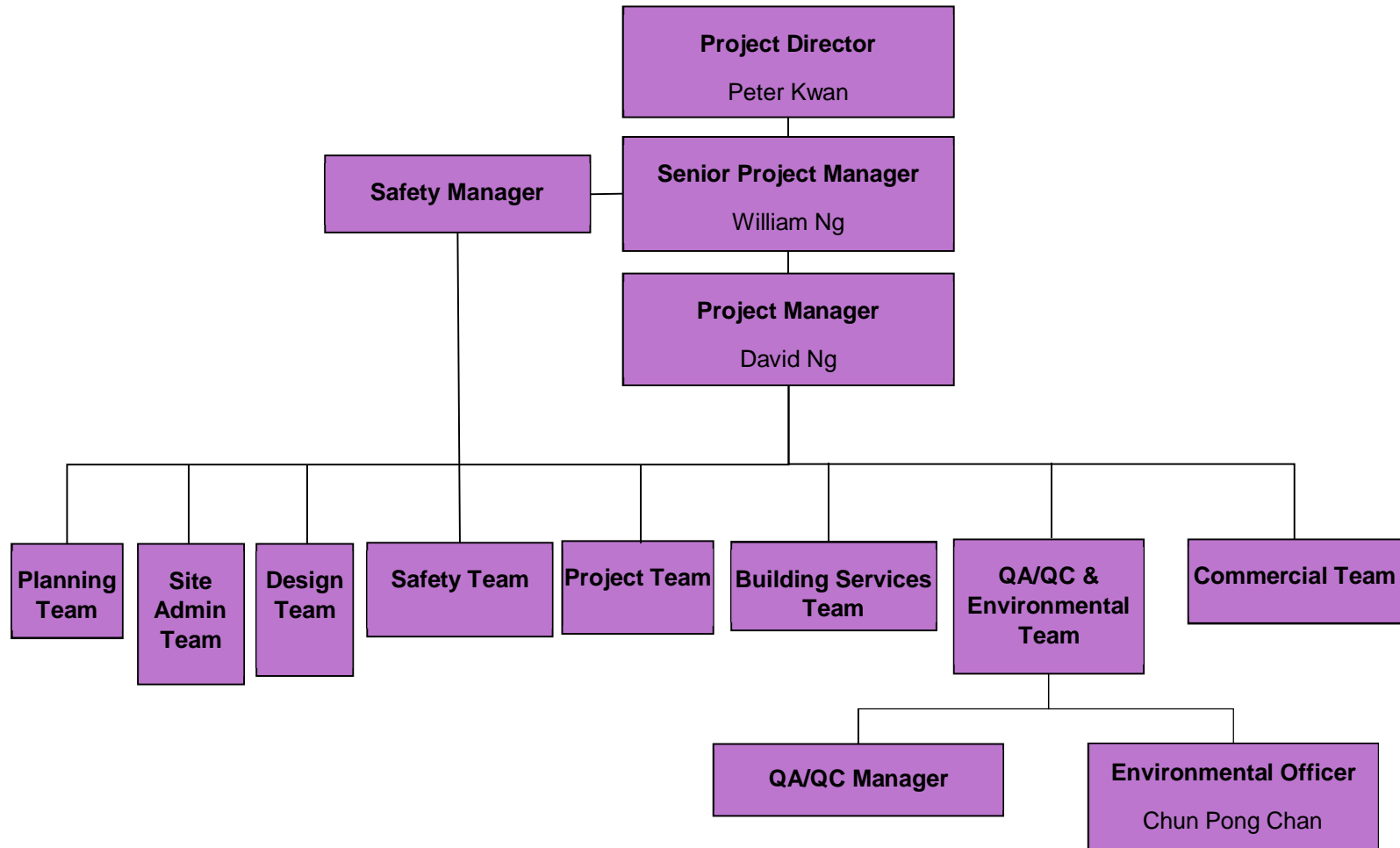
Organization Chart of Wing Hing Construction Co., Ltd. (Contract 3402) for Integrated Airport Centers Enabling Works



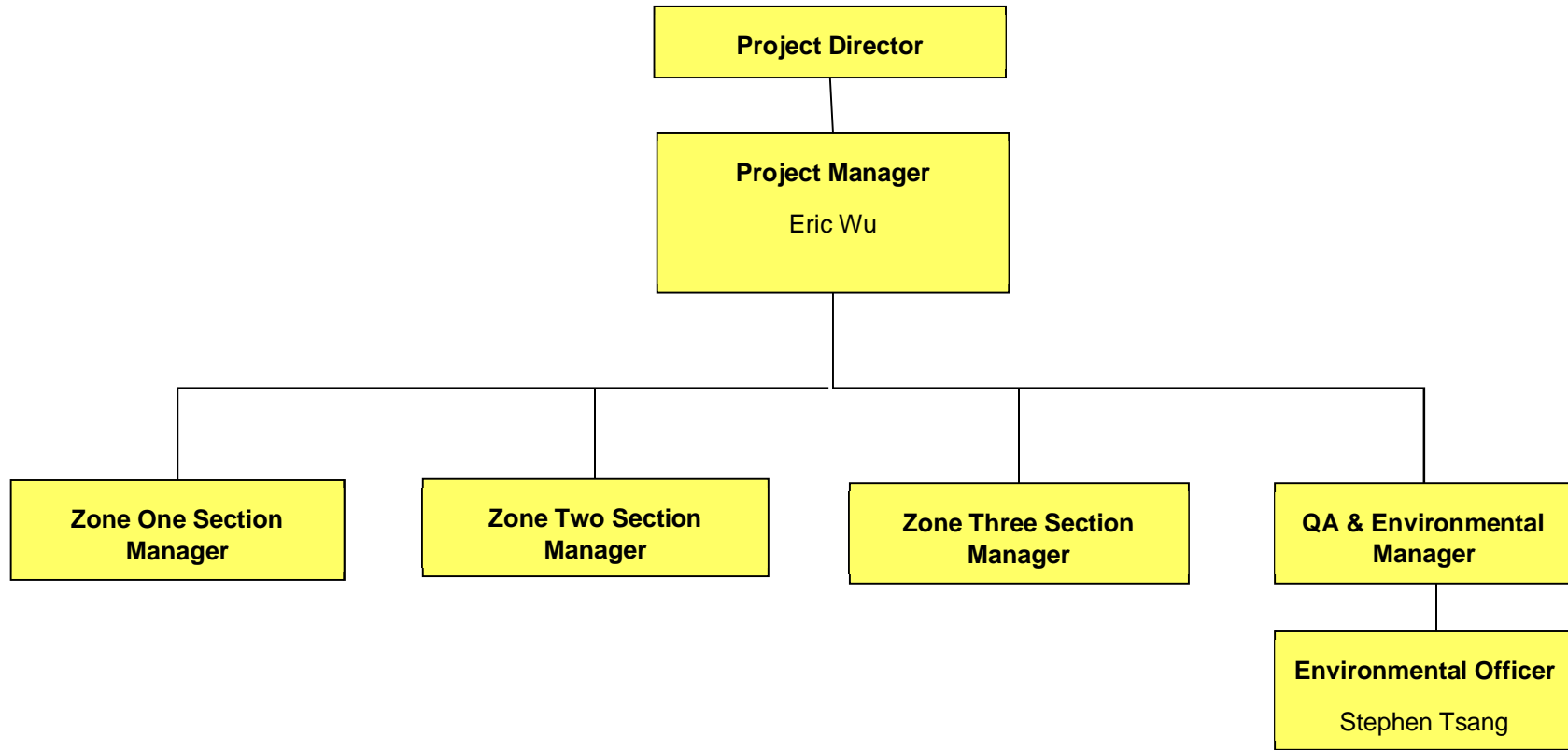
Organization Chart of Build King Construction Ltd. (Contract 3501) for Antenna Farm and Sewage Pumping Station



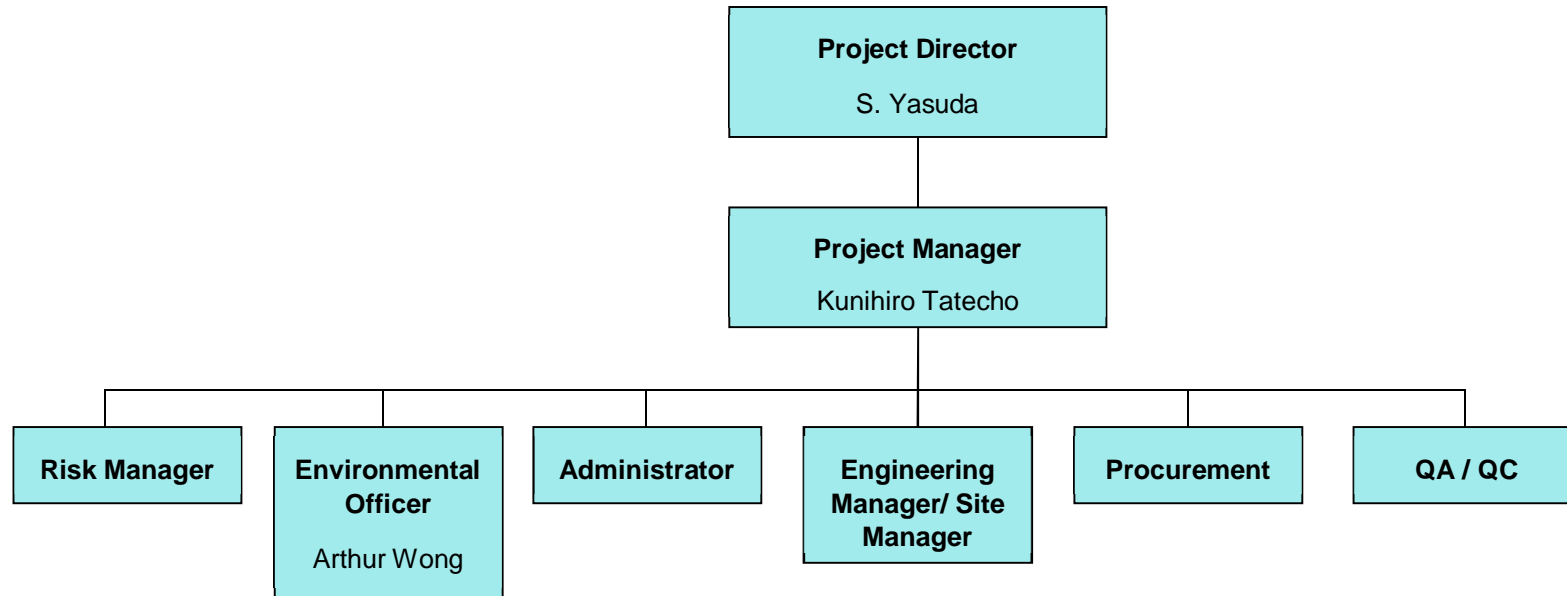
Organization Chart of Build King Construction Ltd. (Contract 3502) for Terminal 2 Automated People Mover Depot Modification



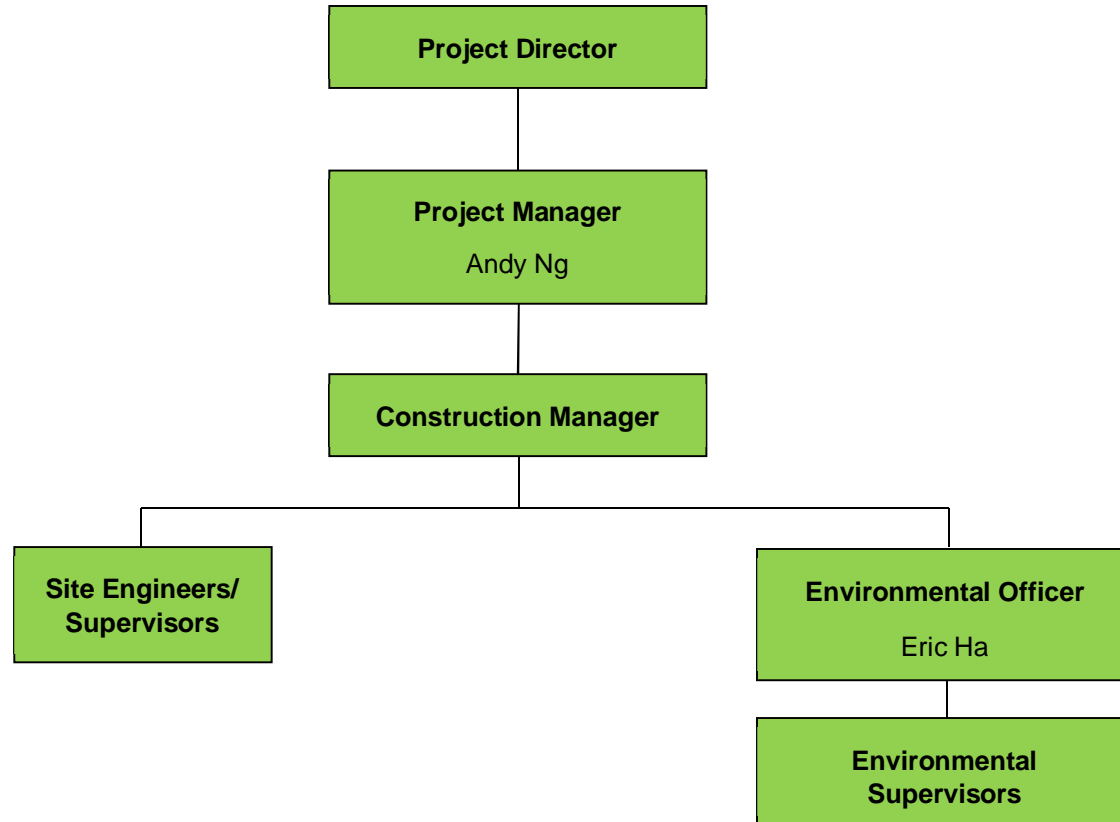
Organization Chart of Leighton – Chun Wo Joint Venture (Contract 3503) for Terminal 2 Foundation and Substructure Works



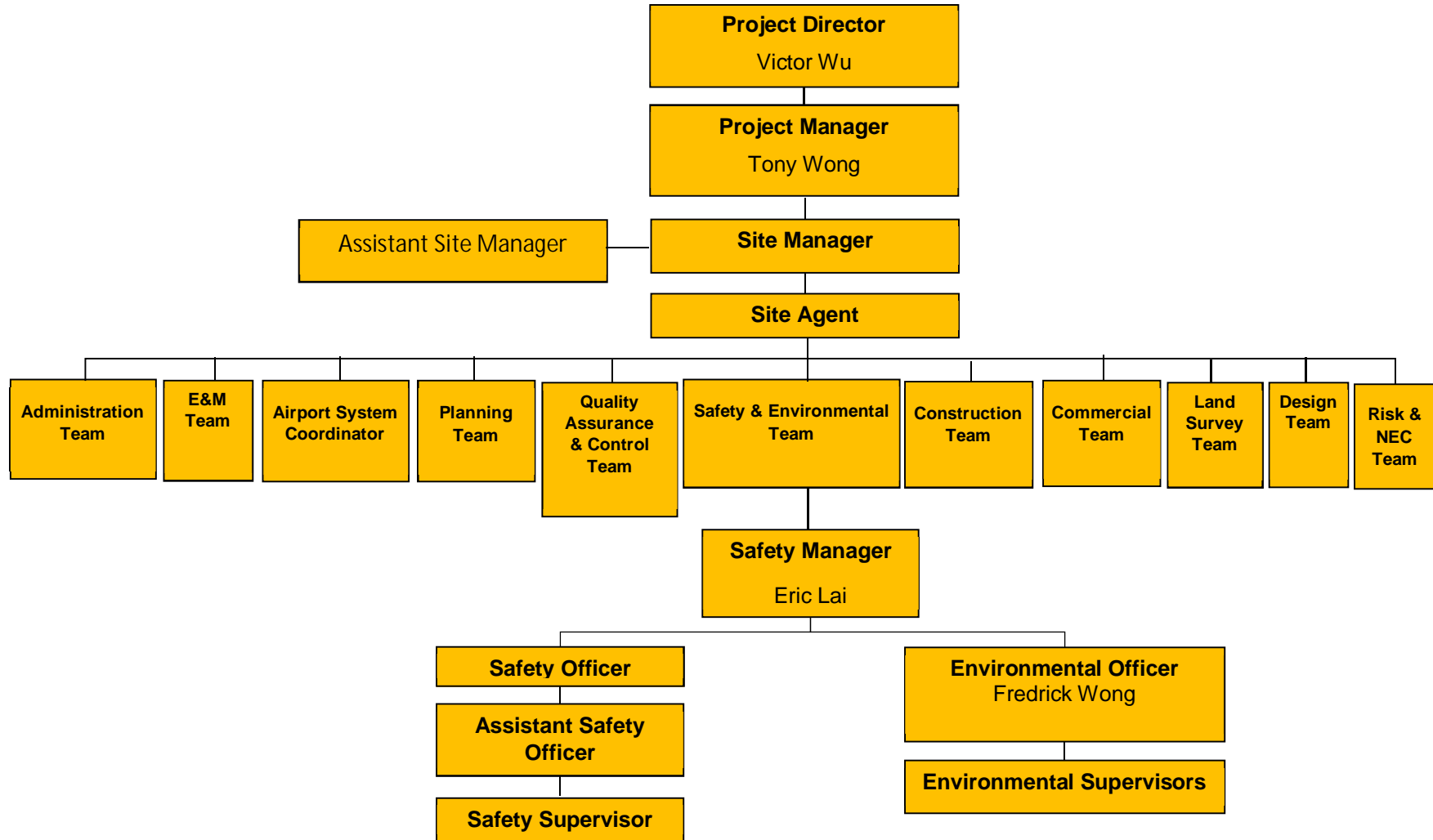
Organization Chart of Niigata Transys Co., Ltd. (Contract 3602) for Existing Automated People Mover System Modification Works
